Trust is the foundation for a successful democracy.

Public trust in government has been put to the test during the Covid-19 crisis, as governments have had to take extraordinary measures to counteract the pandemic. The quality of political leadership has been brought into sharp focus across the world as leaders battled the multiple challenges of the past two years.

Australian governments have managed the crisis reasonably well and we have had far less deaths per head of population than many comparable countries. Public trust in governments in Australia increased in the first 12 months of the pandemic, which helped us achieve our better outcomes. Countries with lower levels of trust had much more difficulty achieving the behaviour changes necessary to combat the pandemic.

Yet we know that trust in government had been declining in Australia prior to the pandemic. This raises the question whether there will be sufficient public trust to tackle the many long term societal challenges that Australia faces including recovering from the pandemic.

There are many building blocks for public trust in government but competence, integrity and openness in our political leaders are vital. The McKinnon Institute is dedicated to enhancing the skills of our political leaders and thereby building public trust. We do this by providing professional development courses for Members of Parliament that are non-partisan, relevant and practical.

Like all organisations we have had to change our operations this year and largely pivot to on-line. Despite this we were able to deliver our flagship Advanced Political Leadership course to a dedicated cohort of Federal and State members of Parliament who are potential Ministers. We also delivered our Political Leadership 2021 course to a group of State MPs from Queensland, New South Wales, Victoria and Western Australia.

We are fortunate to have developed a faculty for our courses of former leaders, ministers and chiefs of staff from the major parties, some of Australia's most respected public service leaders and global thought leaders on a range of strategic topics.

The fact that we have such a committed faculty and so many Members of Parliament who have shown support and enthusiasm for our programs demonstrates the strong appetite for improving the quality of our political leadership and building public trust in Australia's democracy.

In another year when big disruption was an everyday challenge, the McKinnon Institute delivered strongly.

We expanded our delivery to include members and senators from the federal parliament as well as MPs from the parliaments of Western Australia, Queensland and the Northern Territory. By the end of 2021, nearly 100 members of parliament had undertaken professional development with the McKinnon Institute through two different programs.

We debuted our flagship and annual program, Advanced Political Leadership – Australia's first leadership program for MPs who are likely to become ministers. We were delighted to receive many more applications for this program than we had places on offer. We are grateful to our independent panel, comprised of the Hon Jenny Macklin, the Hon Mike Baird AO and Professor Peter Shergold AC FRSN for selecting the participants, as well as the many highly notable individuals who were willing to share their knowledge and insights with participants.

We delivered Political Leadership for 2021, as the third iteration of the online Political Leadership program, to MPs from an expanded number of state and territory parliaments. This included MPs who joined us for the first time from Western Australia, Queensland and the Northern Territory, as well as again welcoming MPs from Victoria and New South Wales.

This year's achievements would not have happened without an exceptional team. This includes the board of the McKinnon Institute, and especially the Interim Chair the Hon Professor John Thwaites AM. Monash University has proved to be an outstanding and supportive partner. None of this would be possible without the generous financial support of the Susan McKinnon Foundation, as well as the contribution of the McKinnon Institute staff, who have tackled their work during this second year of the pandemic - and our second year of program delivery - with dedication, creativity and very good humour. We are grateful for the contribution of the McKinnon Faculty: the educators and presenters who have worked with us to develop and deliver exceptional, relevant and practical programs.

The McKinnon Institute is doing something genuinely new in Australia, and it has been fantastic to attract strong support from a highly diverse range of MPs, and from expert presenters. We have carefully assessed and improved programs based on participant feedback, and in 2022 we will focus more closely on the challenge of measuring impact. We also plan a more public consideration of what good political leadership looks like, and we will commence training for brand new members of parliament. We also plan to expand the number of McKinnon staff to support our expanding agenda.

In 2021, the McKinnon Institute ran two programs:

- **Advanced Political Leadership**
(17 May 2021 – 11 March 2022)
- **Political Leadership**
(15 October 2021 – 3 December 2021)

These programs sought to engage and challenge participants, to develop in our political leaders a combination of practical skills, learning mindsets and stewardship responsibility. Our pedagogical approach draws on leading insights from practice, research and education, benefiting particularly from the strong engagement of Monash University expertise.

Advanced Political Leadership (APL) is Australia's first advanced leadership course for members of parliament who are assessed as having the potential to be ministers in the short to medium term. APL is a cohort-based program, with participants selected by an independent panel comprising Peter Shergold AO, Hon Mike Baird and Hon Jenny Macklin.

APL supports participants to reflect on the role of ministers in our governance, their personal leadership needs and challenges, and the strategic policy challenges they and Australia will face over the decade ahead. An advanced program, it provides political leaders with access to the latest global thinking on issues relevant to policy and political leadership.

APL was delivered by program facilitators Professor Rod Glover and Professor Anne Tiernan.

The inaugural APL program was intended to involve a five-day residential intensive in July, supported by four half-day workshops in May, June, August and September. However, the ongoing disruptions of COVID-19 required the program to adapt on a number of occasions. While covering similar material to original plans, the program ultimately involved 16 sessions over the period May 2021 to March 2022.

Delivered with Program Co-Director Professor Anne Tiernan, APL 2021 had three core learning objectives:

- Develop an understanding of the practicalities of the job of a Minister and of the key success factors for a Minister.
- Develop an understanding of the major forces and challenges that Australia's future political leaders will have to manage and meet.
- Develop an understanding of leadership and to consider their personal leadership styles and trajectories.

Two further goals emerged as the program progressed. First, there was deep interest in how to develop, deliver and sustain large-scale policy reform in today's challenging information and political environment. Second, there was a recognition that our political leaders have a stewardship responsibility, as their conduct impacts on the trust and legitimacy of not just themselves but also their parties, parliaments and democracy.

Sessions explored the relationship between ministers and the public sector, delivering policy outcomes, maintaining integrity, empathy and active listening, prioritisation of time and resources, and Australia's major strategic challenges.

Despite the challenge of online sessions, participants carved out space in their busy schedules and took the opportunity to step back and reflect in a non-adversarial context. Notably, participants embraced the opportunity to engage with colleagues from other parties and levels of government.

The inaugural class of McKinnon Scholars graduated at an event at the State Library of Victoria in March 2022. Three McKinnon Scholars – Tim Wilson, James Griffin and Mark Coure – have already been appointed as ministers during 2021, and we anticipate many more to do so in the future.

Political Leadership 2021 was our third iteration of a program that we ran twice in 2020, for the Victorian and NSW jurisdictions specifically. PL 2021 encouraged the participation of parliamentarians from all states and territories, and the program attracted a diversity of participants from Victoria, NSW, Queensland, Western Australia and the Northern Territory.

Each iteration of PL is tailored to the particular political leadership challenges of the time. The program engages politicians on a set of issues that they nominate as directly relevant to their representative roles in their communities and to their stewardship roles as members of a government and/or parliament delivering legislative and social change.

PL2021 involved eight online workshops and enabled MPs to explore strategies to:


- Show leadership, influence policy and achieve change at local and societal levels;
- Manage stress and sustain wellbeing - for self, staff, colleagues and communities; and
- Respond effectively to the emergent economic and social challenges presented by the COVID-19 crisis, and prepare for the recovery beyond it.



By the numbers

The McKinnon is non-partisan and delivers programs to MPs from a diverse range of parties, and to independents. The proportion of party representation among our program participants generally reflects the numbers in their parliaments.


